1. Refundable security deposit is Rs. 300/-
2. One Time Charge is Rs. 200/-
3. Rs. 5/- will be charged for a time slot as rent of the cycle. One time slot is of upto 30 Minutes.
4. Monthly Optional Membership charge is Rs. 150/- and 1st 30 Min. of every trip will be free
5. Recharge will be done in the multiples of Rs. 50/-
6. Card replacement fee Rs. 200/-
7. Validity of smart card will be one year from the date of last recharge.
8. If cycle is not returned within 12 hrs, legal action will be initiated.
9. Self Attested photocopies of ID Proof and Address proof need to be submitted.
10. Any change in address & Mobile no. should be informed to the Delhi Cycles Private Limited.
11. Lock and Helmet attached with the cycle have to be deposited along with the cycle.
12. No cycle will be issued before 30 Minutes of closure time.
13. Delhi Cycles Pvt Ltd reserves the right to change terms and conditions from time to time without prior intimation.
14. Any damages/loss to the cycle will be borne by the commuter.
15. All disputes are subject to Delhi Jurisdiction.
16. **Important:** Cycle Issue and Deposit should be done with swipe of Smart card on Handheld device with Attendant at Delhi Cycles Pvt Ltd's designated Cycle stands only. Depositing cycle elsewhere will be responsibility of Commuter.
17. Only one cycle will be issued against one card.
18. The Delhi Cycles Pvt. Ltd. is neither responsible nor liable to pay any compensation in case of any accident/ untoward incident.
19. Delhi Cycles Pvt. Ltd. has right to reject any application/cancel the card without assigning any reason.
20. Smart card is not transferable.
21. Taxes extra on all charges wherever applicable.

Procedure for Issue and Activation:

1. Commuter can take Application Form from any cycle stands for free.
2. A Commuter can download application form from www.delhicycles.com
3. Smart card will be issued after receiving completed application form with required documents and verification.
4. Activation code will be sent on mobile as SMS after 24 hours and Smart Card can be activated at any station.

Procedure for lost card:

In case of loss of Smart Card, Commuter will inform the call center and get his/her card blocked. Commuter will be responsible for the usage of the smart card upto 8 hours of intimation to call center. A new card will be issued for Rs. 200/-
